Facilitated by BRIDGE-BS and DOORS Projects

The **Black Sea Accelerator** is supporting sustainable blue economy solutions across the Black Sea region, with the aim to foster sustainable and circular innovation in the Black Sea area. The accelerator is promoted in the context of the BRIDGE-BS and DOORS Black Sea R&I projects, funded under H2020. **The call is open for Black Sea based applicants (individuals) but also to non-regional applicants** exporting solutions in the region. More applications are foreseen as the support provided will be offered through training and advisory services provided online. In principle the language of such services will be English but some ad-hoc language might be offered (to be confirmed).

Both emerging and established (market ready) solutions are eligible (Technology Readiness Level 4 and above)
